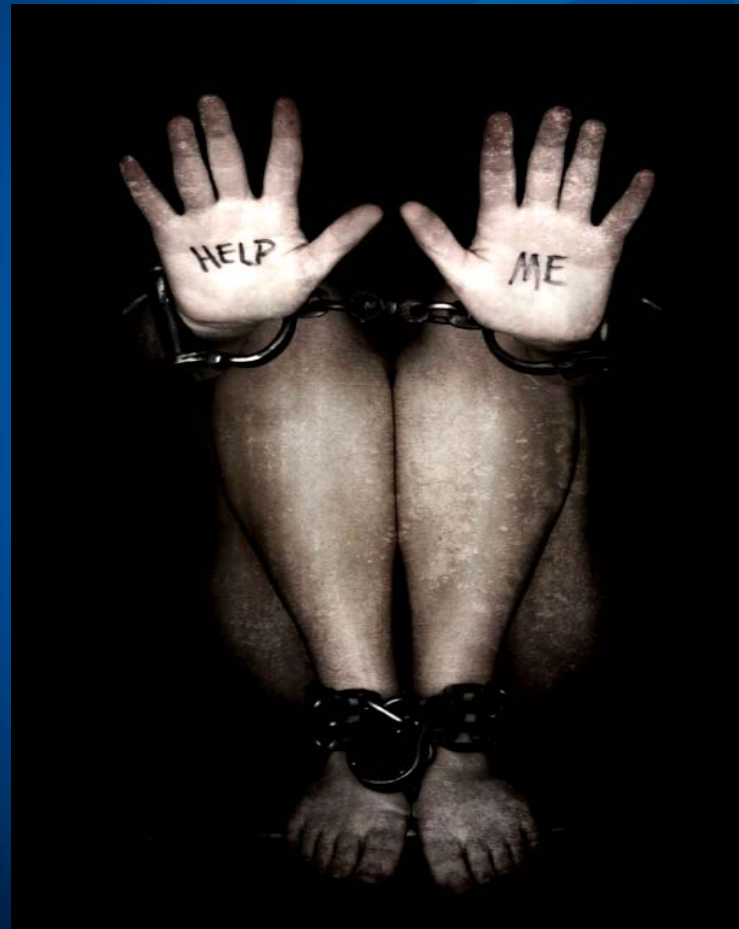

Victim-Centered Approach: Immigration Relief

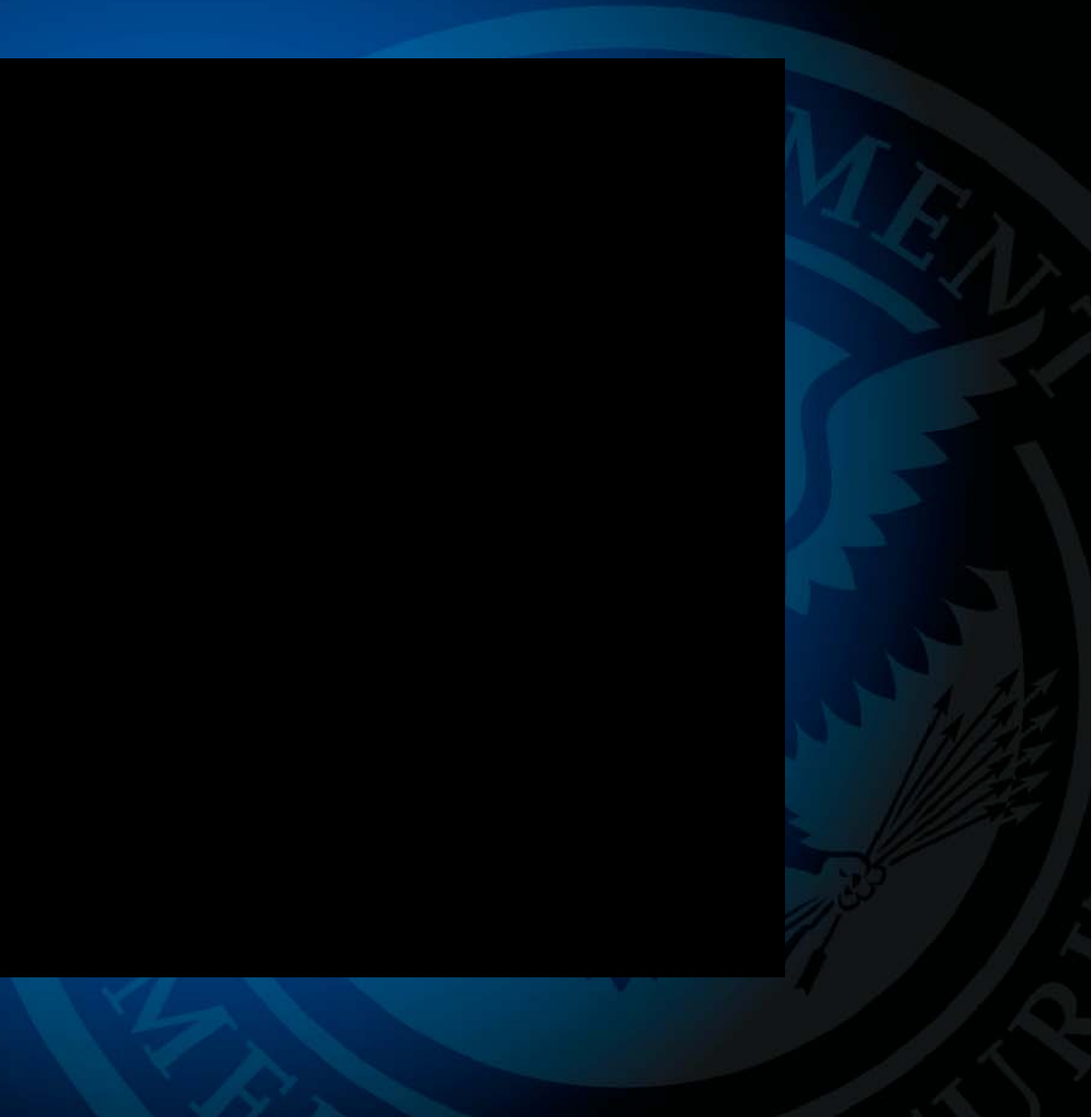
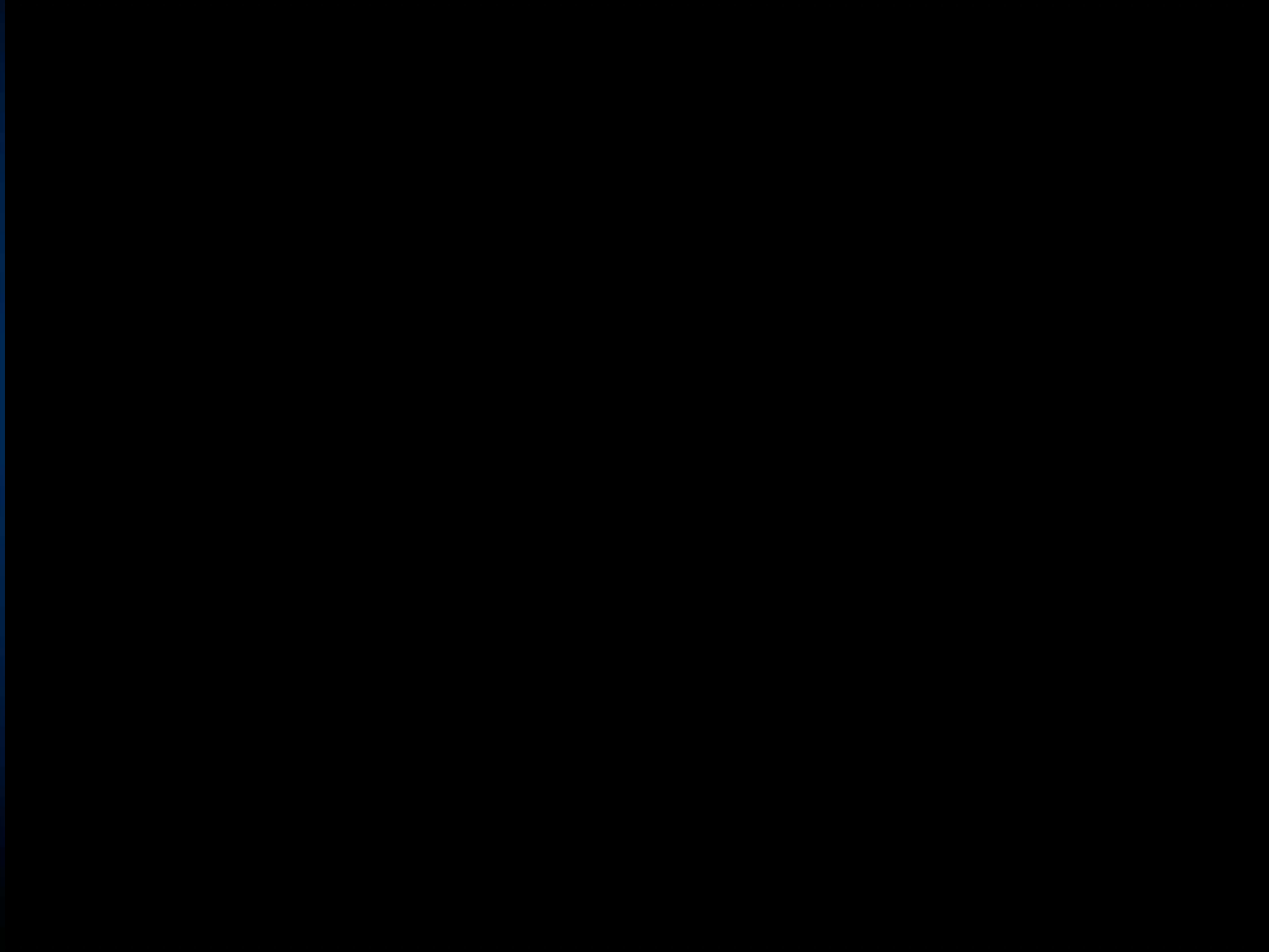
Short-Term Relief

- Continued Presence
 - Only federal law enforcement agencies can apply
 - Granted by ICE
 - Can provide refugee-like benefits

Long-Term Relief

- T Visa
 - Only for trafficking victims
 - Self-petitioned by victim
 - Good for up to 4 years
 - Limited to 5,000
- U Visa
 - Similar to T visa (but covers 28 crimes)
 - Must have LE certification
 - Limited to 10,000

How Many Indicators Did You See?

- Bouncers
- Surveillance cameras
- Loss of free will
- Unwanted touching
- No control of wages
- Unusual living conditions
- Irrational economic conditions
- Intimidation and degrading treatment
- Sub-standard work conditions
